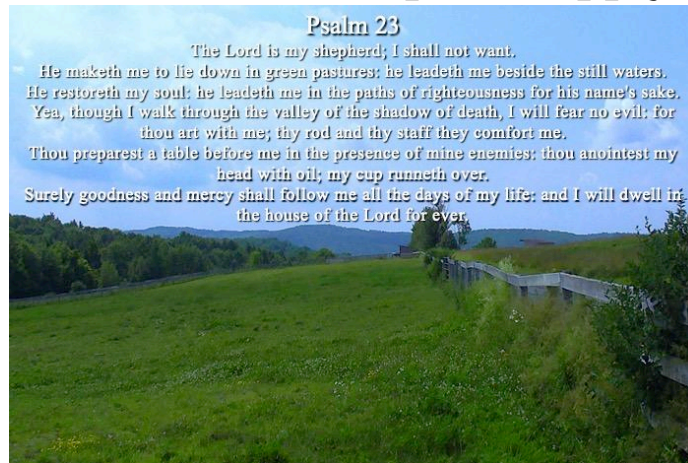


Does The 23rd Psalm Apply To Catholics?

WHO does the 23rd psalm apply to?



The 23rd Psalm is not for those who say “I am saved, I am being saved and I hope to be saved”, as many Catholics are taught to say. Catholics are taught to say that because their false version of Christianity tells them that they cannot know for sure if they possess eternal salvation. In fact, their religion tells them that it is the “sin of presumption” to think that a person can possess salvation... i.e. that they can know for sure that they have unforfeitable (guaranteed) eternal life in Christ.

Therefore, the messages in Psalm 23 are only for those who know for sure that God has granted them salvation, because only those who are truly born again (supernaturally regenerated) by the Holy Spirit can honestly say:

1. The Lord is their Shepherd (verse 1).
2. He leads their soul - through the indwelling Holy Spirit (verse 2).
3. He restored their soul - when they became “born again” and He leads them in the paths of righteousness for His name’s sake - through the Holy Spirit (verse 3).
4. God is with them and watching over them (verse 4).
5. They are no longer God’s enemies (verse 5).
6. They KNOW they will dwell in the house of the Lord forever (verse 6).

Psalm 23

1 The Lord is my shepherd; I shall not want.

2 He maketh me to lie down in green pastures: he leadeth me beside the still waters.

3 He restoreth my soul: he leadeth me in the paths of righteousness for his name's sake.

4 Yea, though I walk through the valley of the shadow of death, I will fear no evil: for thou art with me; thy rod and thy staff they comfort me.

5 Thou preparest a table before me in the presence of mine enemies: thou anointest my head with oil; my cup runneth over.

6 Surely goodness and mercy shall follow me all the days of my life: and I will dwell in the house of the Lord for ever.

Does The Bible Mention The Book Of Maccabees?

Specifically, Does It Mention The Book Of Maccabees In Hebrews Chapter 11?

Hebrews 11:35-38...

35 Women received their dead raised to life again: and others were tortured, not accepting deliverance; that they might obtain a better resurrection:

36 And others had trial of cruel mockings and scourgings, yea, moreover of bonds and imprisonment:

37 They were stoned, they were sawn asunder, were tempted, were slain with the sword: they wandered about in sheepskins and goatskins; being destitute, afflicted, tormented;

38 (Of whom the world was not worthy:) they wandered in deserts, and in mountains, and in dens and caves of the earth.

When examining the claim about Hebrews 11:35 to 38 mentioning the book of Maccabees, it's important to clarify a few points:

These verses describe the sufferings and faith of various figures, but they do not explicitly mention the book of Maccabees. The references are generally interpreted as alluding to events or figures from Jewish history that were well

known to the audience, but not necessarily citing the book of Maccabees directly.

The Canon of Scripture: The Protestant Reformation led to the establishment of a canon that excludes the deuterocanonical books. Martin Luther and other Reformers rejected these books because they did not meet the criteria of the Hebrew Scriptures and were not universally accepted as authoritative by early Christians. This decision was part of a broader effort to return to what Reformers believed to be the original, pure teachings of Scripture.

Historical Context: The books of Maccabees were part of the Septuagint (the Greek translation of the Old Testament), which was used by many early Christians. However, the Reformers decided to adhere to the Hebrew canon, which did not include these books. The New Testament does not explicitly reference the books of Maccabees in a way that would imply their inclusion in the canon. — *HD*

God Only Created Two Genders

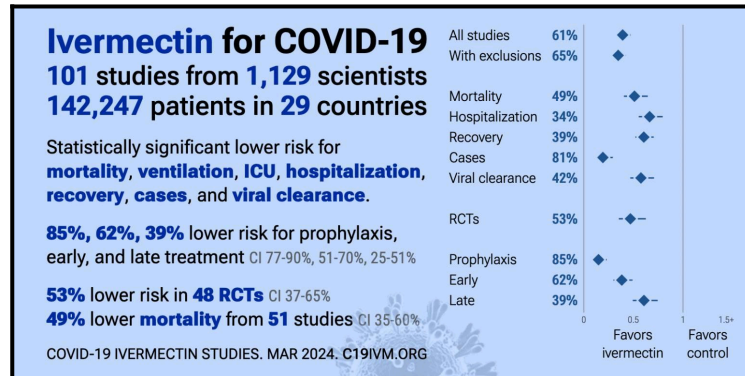
“So God created man in his own image, in the image of God created he him; male and female created he them.” Genesis 1:27

Information In The News About Using Ivermectin To Treat COVID

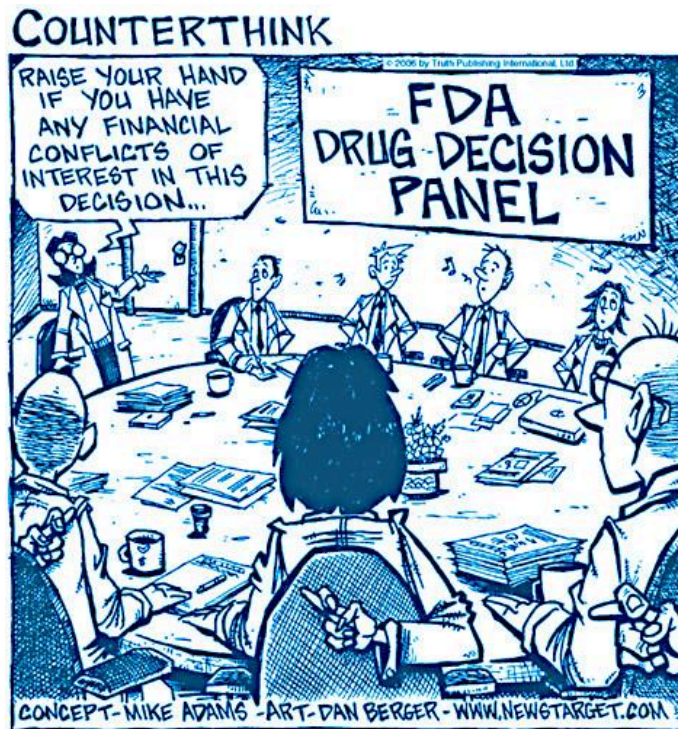
